





A villager informed UN Human Rights Action Team (HRAT) of the murders of **MILANKOVIC LAZAR and ANA**. According to the villagers they had moved from their own village into a house in Knin a few days after the Croatian military attack of 4-5 August. When HRAT members went to the house at Jover Cvejnovica 1, Knin, they observed large bloodstains in the downstairs room where they had been dining. Plates below show bloodsoaked couch and pillow where the body of Lazar had been. Also the remains of a rope, tied to the door sill where the body of Ana was apparently hanging.

On 11 September a passing ECMM patrol spotted the bodies of the dead elderly women piled together by a wall, at the isolated Brud Hamlet, approx. 12 km east of Benkovac. The UN Human Rights Action Team (HRAT) who visited the location were able to identify the women as GRAOVA, Milicia and GRAOVA (first name not known). They had been shot in the head, stomach and to the side of the throat examining the location the HRAT team found blood stains and 4 bulet cartridges (rifle) in the dining room of their house. Apparent from the trail of blood leading from the room to the hallway, was that the bodies had been dragged from the house and dumped by the wall a short distance from the front door. Photos below show the spent bullet cartridges and blood trail in the dining room and the scene of the bodies with a UNHRAT team who re-visited the location with international press on--Sept 1995.


